

PRIVACY POLICY

Your privacy is extremely important to us.

At convertfiles.com (“**ConvertFiles**”, “**Website**”, “**we**”, “**our**”, or “**us**”), we are committed to protecting the information provided to us by our users, including but not limited to visitors to our website, and users who use our services to convert files from one format to another (“**users**” or “**you**”). **ConvertFiles** is bound by the Israeli data protection laws and it is our policy to respect the privacy of individuals and the confidentiality of information provided by our users. This Privacy Policy (“**Policy**”) outlines how we collect, disclose, use, store and handle personal information provided by our users.

Consent. By accessing our website, using any of the services therein, you are consenting to your acceptance of the terms of this Policy. You are entitled to withdraw your consent at any time; however, we may not then be able to provide you with our full range of services.

Updates and Amendments. This Policy will be updated, reviewed and amended from time to time. Please check this Policy regularly to be aware of any updates and changes. Any information collected, used, disclosed, stored or handled by us will be governed by the latest version of this Policy. Material changes (if any) to this Policy will be indicated by a notice on our home page. Continued use of this website, or use of any of the services, will thereafter constitute your deemed acceptance of the revised Policy.

Information we collect about you. ConvertFiles is a website dedicated to allowing users to convert files from one format to another. Our Website is mainly intended for conversion purposes only, and we do not actively seek to collect any personal information about you. At ConvertFiles, though we do not proactively collect any personal information about you, we may collect information which are essential for providing a better and more efficient service to you. We collect and store for a certain time period, files uploaded by you on the Website for conversion (“**File Information**”). These files will be available for the users to download till a period of 24 hours from conversion, or till the maximum download limit has been reached. There is no backup made of the aforesaid File Information, nor does ConvertFiles view the contents of these files without your permission. As we do not collect any Personal Information, we do not and cannot use, disclose, store or handle your Personal Information.

Cookies and anonymous information. Our website uses cookies to record anonymous information for analytics and other purposes, which helps us improve our website’s experience

continuously. Please change your browser settings if you do not wish to accept cookies. Such information may include anonymous information which is automatically logged each time you visit our Website, including the type of browser you are using, the server name and IP address, the pages you access, or the source from which you linked to the ConvertFiles Website (together, “**Anonymous Information**”).

IP Address When visiting convertfiles.com , the IP address used to access the site will be logged along with the dates and times of access. This information is purely used to analyze trends, administer the site, track users movement and gather broad demographic information for internal use. Most importantly, any recorded IP addresses are not linked to personally identifiable information.
